Each recipient is selected by his peers based upon outstanding professional growth, program effectiveness, leadership ability, loyalty to Extension work, civic, community involvement, and must have been a NACAA and TCAAA member for ten or more years.

All Distinguished Service Award recipients will be honored at the Galaxy IV Conference to held July 20-24, in Mobile, AL.

#### **Distinguished Service Award**

**Bryan Reynolds**Lynn County



Bryan Reynolds has served the Texas AgriLife Extension Service for more than 21 years. He began as an Assistant County Extension Agent for Agriculture in Castro County in 1992. In 1994, Bryan moved to Lynn County to serve as the County Extension Agent for Agriculture where he currently serves today. Bryan has demonstrated effective agricultural programming efforts with Lynn County cotton growers whom typically plant more than 300,000 acres annually. He assisted growers with the Boll Weevil Eradication Program, saw them adopt new cotton varieties to improve yields and has educated them on nematode management as it affects their cotton. Bryan has also had programs in small grains, livestock and water conservation. He has had an active and successful 4-H program over the years. His 4-H members have been very successful with their beef and swine projects at shows across Texas. In addition, Bryan has had outstanding leaders who have implemented a quality 4-H Shooting Sports program. He has taught numerous 4-H members to evaluate livestock along with helping them to develop their communication skills through public speaking. Bryan has served as chairman of the Bob Benson/EXCELL 4-H Scholarship Golf Tournament which raises funds for 4-H members across the South Plains. He served as secretary to the Texas County Agricultural Agents Association, received the Achievement Award from the National Association of County Agricultural Agents and the Meritorious Service Award from Texas 4-H.

An adult leadership program "Leadership Coryell" was established to identify and involve potential community leaders and give them skills needed to be successful.

#### **Distinguished Service Award**

**Cullen D. Tittle**Brazos County



Cullen D. Tittle has served with the Texas A&M AgriLife Extension Service for 21 years. His career began in August 1993 as an assistant agent in Wilbarger County and continued in Falls, Milam and Burleson Counties. Currently, he serves as County Extension Agent for Agriculture and Natural Resources in Brazos County. During his career, he has developed educational programs addressing warm-and cool-season forage production; provided leadership in cotton, corn, sorghum and soybean cropping systems; worked with landowners to create a Wildlife Management Association and implemented effective supplemental food plot programs; established numerous brush/weed management trials and; worked closely with small ruminant producers. Regarding 4-H, Cullen emphasized 4-H is a family oriented program that is best managed by local volunteers. He assists adult volunteers in directing extremely active programs in shooting sports (rifle, air rifle, air pistol and archery), horse, livestock judging, and livestock exhibition utilizing youth and adult volunteers as program mentors and speakers during livestock camps, clinics and tours. Cullen's most rewarding moments have been seeing constituents, adult and vouth, achieve their goals and realize their potential.

# **Benji Henderson** Parmer County



Benji has worked to aid Parmer County producers through education on new technology and production practices to improve profitability and sustainability related to improved cotton varieties. The ultimate goal is to maintain cotton production as viable agronomic production system in Parmer County. The Parmer Ag Committee has been a large part of the planning and implementation process in the cotton work with recommendations and planning out of meetings and demonstrations. The members of the Parmer County Ag Committee are all local producers within the county. Each of them either currently grow cotton or have grown cotton in the past years and are actively searching for information to help keep cotton as a viable option for themselves and other producers in the county. Additionally, there have been educational programs in silage production, vegetables, wheat production, corn production, stocker cattle, grain sorghum production and water use. Parmer County is one of the most diverse counties in the Texas Panhandle. There is significant production in vegetables such as black-eved peas and green beans. In combination to cropping there are over 13 operating dairies and six large feedlot operations in the county. Many producers also run stocker cattle on wheat in the winter months. There have also been many diverse crops such as sesame and Swiss chard. As an example to this there have been numerous cotton variety trials, fly trapping demonstration in dairies, and moth trapping projects. Diversity in programming efforts have been key and working with key stake holders in the county to help maintain a relevant program which feeds the needs of many producers rather than focusing on only a few project areas. There is also a very active 4-H program in the county with youth exhibiting livestock projects, judging, horse shows, and actively pursuing many of the programs offered at the county, district, and state levels. Johnson County



Zach Davis began his career as County Extension Agent – 4-H in Johnson County in 2006, and has been serving Johnson County as Agriculture Agent since 2010. He works to build an effective, well-rounded Extension program including beef and forage management, new and small landowner education, and 4-H agriculture projects. Since 2010, outcome program efforts have garnered an attendance of 853 clients representing 71,065 acres of agricultural property with an estimated economic impact of \$745,195.

#### **Achievement Award**

**Phoenix Rogers**Galveston County



Phoenix Rogers joined Extension in 2007 as the County Extension Agent for Agriculture/Natural Resources in Calhoun County and has served in Galveston County since 2009. Working with local producers and committees, Extension faculty, and other agencies, Phoenix has implemented programs addressing current and emerging issues for various topics, including livestock and forage production, watershed management, and 4-H livestock activities. Phoenix received her B.S. from New Mexico State University and her M.S. from Washington State University.

#### **Achievement Award**

**Jason Ott** Medina County



Jason Ott has served as a county extension agent for nine years; primarily in Medina County. On October 1, 2013 Jason transferred to his present position in Nueces County. Jason's primary focus has been on soil fertility and water conservation for row crop producers. Surveys valued the programs economic benefit to growers at \$12.17 per acre last year. Jason also served as 4-H Coordinator and was heavily involved in providing leadership and training to club managers, volunteers and youth. As an agent, Mr. Ott coordinated four annual prospect shows for the Medina County Fair Association. These shows generated over \$67,000 in revenue from out-of-county participants annually. As an advisory member on the county stock show board, Mr. Ott was able to guide them into managing their own youth auction. This allowed them to retain their own commission from the sale, eliminating \$50,000 in debt while continuing to allow them to make improvements to their infrastructure.

Michael R. Hiller Jackson County



Mike Hiller began his career as County Extension Agent in 2006. He provides leadership to diverse audiences including 4-H youth activities, beef & forage production, field crops & rice production, natural resources and a Master Gardener program. Mike uses bi-weekly radio programs, newsletters, news articles, result demonstrations and one on one consultation with producers to accomplish program results. The latest major accomplishment has been the establishment of the Annual Premium Bull and Replacement Female Sale.
